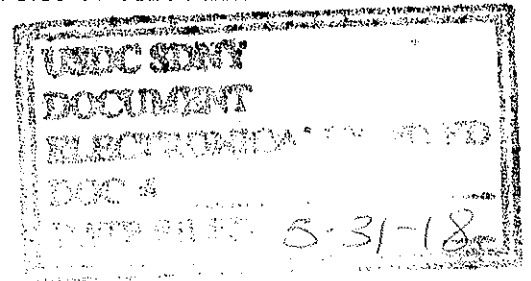

~~PROPOSED~~ ORDER GRANTING GEORGE LEHMANN AND INSURED BENEFIT
PLANS, INC.'S MOTION FOR APPOINTMENT AS LEAD PLAINTIFF AND
APPROVAL OF LEAD COUNSEL

WHEREAS, the above-captioned putative class action asserting claims under Sections 10(b) and 20(a) of the Securities Exchange Act of 1934 (the "Exchange Act") was filed in the Southern District of New York; and

WHEREAS, George Lehmann and his solely-owned corporation Insured Benefits Plans, Inc. (collectively, "Lehmann") filed a timely motion to be appointed Lead Plaintiff; and

WHEREAS, Lehmann has the largest financial interest in the relief sought by the Class and otherwise satisfies the requirements of Section 21D of the Exchange Act and Rule 23 of the Federal Rules of Civil Procedure; and

WHEREAS, in accordance with Section 21D(a)(3)(B)(v) of the Exchange Act, 15 U.S.C. § 78u-4(a)(3)(B)(v), Lehmann seeks approval of his selection of Faruqi & Faruqi, LLP to serve as Lead Counsel for the Class.

AND NOW THIS ____ day of _____, the Court having considered Lehmann's Motion for Appointment as Lead Plaintiff and Approval of Lead Counsel, and all supporting documents, and good cause appearing therefore, it is hereby ORDERED as follows:

LEAD PLAINTIFF

1. The motion of Lehmann to serve as Lead Plaintiff in the Action is GRANTED. Pursuant to Section 21D of the Exchange Act, 15 U.S.C. § 78u-4(a)(3)(B), Lehmann is appointed as Lead Plaintiff for the putative Class.

LEAD COUNSEL

2. The motion of Lehmann for approval of his counsel to serve as Lead Counsel is GRANTED. Pursuant to Section 21D of the Exchange Act, 15 U.S.C. § 78u-4(a)(3)(B)(v), Faruqi & Faruqi, LLP is approved to serve the Lead Plaintiff and the Class as Lead Counsel.

IT IS SO ORDERED.
